

## Terms and Conditions

**WARRANTY:** QUARRY CONNECTIONS LLC MAKES NO WARRANTIES, EITHER EXPRESSED OR IMPLIED, REGARDING THE MATERIAL IT SUPPLIES. UPON SIGNATURE, BUYER FULLY ACCEPTS MATERIAL AND IS IN FULL AGREEMENT WITH THE ACCURACY AND QUANTITY BILLED. USE CONSTITUTES ACCEPTANCE.

**RETURN MATERIALS:** It is the Customer's obligation to immediately inspect product and notify Quarry Connections LLC of any defective, missing or non conforming product. Failure to notify Quarry Connections LLC in writing within 7 business days constitutes acceptance of product as shipped. No materials may be returned without prior approval of Quarry Connections, LLC. A restocking fee of 25% will be applied to any resalable material in original packaging returned within 30 days. No returns on material over 30 days or special orders.

**PAYMENT GUARANTEE:** Purchaser (including Owner(s), Principal(s), Heir(s) and/or Assign(s), agrees by accepting delivery of the items, to assume full and complete responsibility for payment thereof, according to Seller's terms and conditions, as specified herein, Purchaser further agrees to reimburse Seller for any and all expenses of any kind to include, collection suit fees, attorney's fees and/or court costs incurred in an effort to obtain payment for this purchase.

**PAYMENT TERMS:** Pricing is based on cash/check discount or established account terms. A 5% convenience fee will be charged for credit card payments. Credit card transactions agree to pay invoices according to the credit issuer agreement. Payment is COD unless established account is within terms. Past due accounts will be closed until the account is paid in full. Customer agrees that the Seller has the right to determine, in its sole discretion, how to apply payments and which invoices to pay with payments received on account.

**LATE CHARGES:** All invoices are to be paid promptly according to the credit terms established. Failure to comply with the credit terms established may result in cancellation of credit privileges without notice. All accounts past due will bear a service charge from the due date at the rate of 1.5% per month (18% APR). Quarry Connections LLC reserves the right to assess finance charges on overdue finance charges.

**SERVICE CHARGES:** A Service Charge of \$35.00 will be applied to the account for any Returned Checks.

**PRICES:** Prices are for material costs only and do not include freight charges. Pricing is for full pallet quantities only. Prices are subject to change without prior notice and to correct for errors. Fuel surcharges may be added due to market conditions.

**STONE MASONRY PRODUCTS:** Stone is a product of nature and will vary in color, markings, textures and dimensions. Stone samples are used to show the general range of color and texture. Quarry Connections LLC recommends the purchase of all material required to complete a project in order to maintain color consistency. The appearance and coverage of stone in the final product is affected by the installation method, setting style and job design. All materials should be inspected prior to installation. Quarry Connections LLC does not assume responsibility for material after it has been installed and will not pay for labor costs to remove such products.

**STONE SAMPLES:** Samples provided by Quarry Connections LLC represent the general characteristics of the stone. Natural variations can and will occur in size, color and texture. Stone, as it ages, can change color on the outer surface. Stone can oxidize, darken, lighten or otherwise change from the appearance either shown in sample walls or marketing materials. Installation or specific structural questions should be addressed to the builder, architect or qualified professional.

**DELIVERIES:** All delivery locations must allow for truck access. For deliveries where customer is responsible for offloading, proper equipment must be available at delivery location to offload pallets. Quarry Connections LLC reserves the right to assess detention time for delivery delays. Independent haulers will provide curbside delivery. In consideration of delivery onto the premises, the purchaser does hereby agree to indemnify and hold harmless Quarry Connections LLC and its employees, subcontractors, or independent contractors of all claims on account of an unintentional trespass or damage to any of the said premises or improvements thereon, or to any of the said deliveries, notwithstanding sellers exercise of ordinary care. Delivery will not be permitted in any area where risk of injury to driver, and/or bystanders, and damage to vehicle exists. Quarry Connections LLC is not responsible for any property damages, or claims or liability caused beyond the curb line.
